# Broad Oak Primary School Relationships and Sex Education (RSE) Policy (Draft)

Broad Oak Primary School is a Rights Respecting School, any articles from the UN Convention on the Rights of the Child which apply to this policy are detailed below.

#### Article 2

The Convention applies to every child without discrimination, whatever their ethnicity, gender, religion, language, abilities or any other status, whatever they think or say, whatever their family background.

#### Article 16

Every child has the right to privacy. The law should protect the child's private, family and home life, including protecting children from unlawful attacks that harm their reputation.

#### Article 24

Every child has the right to the best possible health. Governments must provide good quality health care, clean water, nutritious food, and a clean environment and education on health and well-being so that children can stay healthy. Richer countries must help poorer countries achieve this.

#### Article 28

Every child has the right to an education. Primary education must be free and different forms of secondary education must be available to every child. Discipline in schools must respect children's dignity and their rights. Richer countries must help poorer countries achieve this.

#### Article 29

Education must develop every child's personality, talents and abilities to the full. It must encourage the child's respect for human rights, as well as respect for their parents, their own and other cultures, and the environment.

#### Article 34

Governments must protect children from all forms of sexual abuse and exploitation.

## Article 36

Governments must protect children from all other forms of exploitation, for example the exploitation of children for political activities, by the media or for medical research.

# Introduction - School Setting

Broad Oak Primary School is a community primary school situated in Didsbury for pupils aged between 3-11 years. The school serves a diverse mix of children and families. 27% of pupils speak English as an additional language (EAL), 12% of pupils are entitled to a free school meal and 16% of pupils are identified as having a Special Educational Need or Disability (SEND). The school will ensure that Relationships and Sex Education (RSE) will meet the needs of all pupils in accord with,

**Article 2:** 'The Convention applies to every child without discrimination of any kind, irrespective of the child's or his or her parent's or legal guardian's race, colour, sex, language, religion, political, or other opinion, national, ethnic or social origin, property, disability, birth or other status.'

# Rationale and Legal responsibility

This policy ensures the requirements of the National Curriculum 2014 for Science, the non-statutory framework for Personal, Social and Health Education (PSHE) and Citizenship at Key Stages 1 and 2 and the compulsory expectation Relationships and Sex Education (RSE) as of September 2020. The policy was developed in consultation with staff and governors of the school. It is intended to be used as an outline to the guiding principles of how RSE is taught at Broad Oak.

## Vision, Values and Ethos

'Broad Oak Primary School delivers the very best educational experience with a dynamic and motivating curriculum to excite all minds. All of our teaching and learning is underpinned by our core values: **Attitude**, **Behaviour**, **Friendship**, **Courage**, **Determination**, **Enthusiasm**, **Resilience**.'

The policy has been written to support the school's Vision and Aims and the following statements regarding Relationships and Sex Education:

- Through RSE, Broad Oak Primary School supports children to become global citizens equipped
  with the knowledge and the skills for a rapidly changing world, understanding the inter-dependence
  of individuals, groups and nations.
- The RSE curriculum will be taught through a caring, supportive learning environment where there is equal opportunity regardless of gender, race, culture, disability, or social standing.

### **Definition of RSE**

## RSE is

'learning about the emotional, social and physical aspects of growing up, relationships, sex, human sexuality and sexual health. Some aspects are taught in Science, and others are taught as part of Personal, Social, Health education (PSHE). A comprehensive programme of RSE provides accurate information about the body, reproduction, sex and sexual health. It also gives children and young people essential skills for building positive, enjoyable, respectful and non-exploitative relationships and staying safe both on and offline.'

# Aims

The overall aim of RSE is to foster a positive notion of lifelong learning about physical, moral and emotional development, including how to look after physical and mental health. It aims to support the development of self- respect and empathy for others and promotes the development of skills and understanding necessary to manage conflict peaceably and learn how to recognise and avoid exploitation and abuse.

### **Objectives**

- To provide the knowledge and information to which all pupils are entitled
- To clarify/reinforce existing knowledge
- To raise pupils self-esteem and confidence, especially in their relationships with others
- To understand the importance of safe and stable relationships that promote respect, love and care
- To help pupils develop skills (language, decision making, choice, assertiveness, resilience) and make the most of their abilities
- To provide the confidence to be participating members of society and to value themselves and others
- To help gain access to information and support
- To develop skills for a healthier safer lifestyle
- To develop and use communication skills and assertiveness skills to cope with the influences of their peers and the media
- To develop resilience and positivity when responding to influences that may affect body image
- To reinforce and develop pupils' understanding of how to stay safe online
- To respect and care for their bodies
- To be prepared for puberty and adulthood
- To respond to the needs of pupils and parents/carers by providing accurate knowledge of sexual
  matters at a level suitable to each child's age and understanding, dispelling myths and addressing
  misunderstandings.
- To foster an understanding and acceptance that relationships can be formed in diverse and varied ways, for example, between people of the same gender.
- To understand that families take on many forms and to be sensitive about the families of those around them

### Teaching and delivery of the curriculum

RSE will be delivered by teaching staff that are trained, able in the planning, delivery and assessment of the RSE curriculum, equipped to handle sensitive issues and able to answer both pupil and parent questions. External healthcare professionals will be used to enhance the teaching of RSE.

## The RSE curriculum

From June 2021, RSE lessons will follow the primary 'I matter' curriculum.

### **Evaluating and monitoring learning**

To ensure that the curriculum content and teaching is effective, the delivery of RSE will be assessed and evaluated in the classroom.

The implementation of the RSE curriculum will be monitored through observation, staff and pupil voice. Pupil voice activities may include 'draw and write' activities, surveys, pre- and post-topic mind maps, evaluation sheets and discussion.

# **Confidentiality and Child Protection Issues**

A child's confidentiality may not always be maintained by the teacher or member of staff concerned. RSE discussions or lesson content may prompt a pupil to disclose about related incidents. For example, Female Genital Mutilation (FGM), forced marriage, child exploitation or abuse. If this occurs, or a member of staff believes that the child is at risk of harm or has concerns about any information disclosed, the staff member must inform the named Designated Safeguarding Lead and follow the procedure set out in the Safeguarding/ Child Protection Policy.

Broad Oak is committed to ensuring that issues are taught in a way that does not subject pupils to discrimination. Teaching will be accessible to all children, including young people who are lesbian, gay, bisexual and transgender (LGBT) and respect how pupils choose to identify themselves both in terms of gender and sexual identity.

### **Right of Withdrawal**

Broad Oak Primary school will inform parents when aspects of the Sex Education programme are taught and will provide an opportunity for parents to view a sample of the resources used in lessons.

Parents have the right to withdraw their children from those aspects of Sex Education that are not included in the Science Curriculum. Parents will be notified in advance of any Sex Education teaching and informed of how they can withdraw their child if they choose to. Alternative work will be set for children who have been withdrawn from these lessons. Relationships Education is a statutory part of the school's curriculum and, consequently, parents may not withdraw pupils from these lessons. However, in view of the cross curricular nature of the school's teaching, it is impossible to guarantee that any child will be excluded from discussions of RSE matters which may arise outside specific sex education lessons.

Parents need to be aware that RSE can occur at any time if it arises naturally from class discussion. The school strongly encourages parents to support the school in the teaching of RSE.

If a parent/carer wishes to withdraw their child from aspects of RSE curriculum they should complete the request for withdrawal form (Appendix 3) making it clear which aspects of the programme they wish their child to be withdrawn from.

## Review of this policy

This policy is reviewed at least every two years and also in the light of any related issue that may occur such as any new findings arising from educational research, local or national guidance.
